

This is the Forty Hill CE Primary School Publication Scheme on information available under the Freedom of Information Act 2000

The governing body is responsible for maintenance of this scheme.

1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- *The classes of information which we publish or intend to publish;*
- *The manner in which the information will be published; and*
- *Whether the information is available free of charge or on payment.*

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is available in paper form at a charge of 50p per copy.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2. Aims and Objectives

We aim to serve the local community and we welcome children from not only Christian families, but from other faiths and backgrounds.

We believe in providing a welcoming and secure environment in which Christian beliefs and values are encouraged in the life of the school. Our shared aim is to provide a positive, well-structured curriculum within a disciplined and purposeful framework. We aim to develop the whole child: socially, physically, academically, emotionally, spiritually and morally. In order to achieve this the school strives to maintain a calm, happy, caring and stimulating atmosphere in which the children can learn and develop.

We strive to help pupils develop into knowledgeable, skilled, responsible and caring adults. We value the diversity of our community and aim to work in partnership with all its members.

We believe in the importance of developing positive attitudes to learning and in teaching the basic skills of reading, writing, speech and numeracy so that children can access a wide variety of learning and develop the necessary skills for reasoning and problem-solving.

We aim for the children to be self-disciplined. Rules are few and they are underpinned by the School Behaviour Policy. Classes work on class agreements at the beginning of the school year which establish a framework for conduct. The children are encouraged to be aware of the safety and welfare of the whole school community.

This publication scheme is a means of showing how we are pursuing these aims.

3. Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

School Prospectus – information published in the school prospectus.

Governors' Documents – information published in the Governors Annual Report and in other governing body documents.

Pupils & Curriculum – information about policies that relate to pupils and the school curriculum.

School Policies and other information related to the school - information about policies that relate to the school in general.
